## REGULATIONS

### ARTICLE 1

The web magazine *Olio Officina* and the bilingual Italian/English printed edition of *OOI International Magazine* are holding a special contest, to mark the eleventh edition of the *Olio Officina Festival* - an event that will take place **from 10 to 12 February 2022 in Milan - aimed at olive oil millers who have invested not only in machinery and equipment**, focusing on oil production quality, **but also in architectural and design solutions, focusing on aesthetic and functional quality in order to highlight the value of beauty.**

### ARTICLE 2

The **contest is open** to all olive mill owners from any oil-producing country.

### ARTICLE 3

**There are no enrolment fees, but entry to the contest is reserved exclusively for subscribers** to the print version of *Olio Officina International Magazine* **or, by extension, to subscribers to the free newsletter from the *Olio Officina* information portal ([www.olioofficina.it](http://www.olioofficina.it)).**

This condition also applies if you subscribe to the magazine at the same time as registering for the contest, or if you subscribe to the free newsletter from the information portal.

### ARTICLE 4

Any oil millers wishing to nominate their olive oil mill must indicate **all details** relating to the exact location of the mill, including the street address, municipality, province, region, country, as well as the website and the name of a contact person.

### ARTICLE 5

Anyone wishing to nominate their mill for *The Awesome Oil Mill Contest* is also requested to provide **detailed information** on their operating structure: extraction method(s), number of production lines, whether they carry out subcontracting and/or packaging services, and to indicate whether their mill has its own analysis laboratories, panel rooms, tasting rooms for the public, conference rooms, points of sale, newspaper collections or libraries, museums or exhibition spaces.



## REGULATIONS

### ARTICLE 6

In order to judge the olive mills in the competition, it is **expressly requested that any photographic and/or video material that may be useful** for highlighting all the qualities of the mill, **including any architectural design plans, be submitted along with the application.**

### ARTICLE 7

**Registration** for *The Awesome Oil Mill Contest* must be submitted at the same time as the supporting materials for the contest **by 10 January 2022 at the latest.**

**The supporting documents** needed for the competition **should be sent to the e-mail address [posta@olioofficina.com](mailto:posta@olioofficina.com), or by post to the address of the Olio Officina editorial office:** via Giovanni Rasori 9 - 20145 Milano, Italy.

### ARTICLE 8

**The jury**, made up of a core group of people professionally qualified to assess the various features that make up the olive mill structure, will give its verdict, which will be announced on the information portal of *Olio Officina magazine*.

### ARTICLE 9

**The award ceremony will take place on Saturday 12 February 2022 in Milan, during the eleventh edition of the Olio Officina Festival.**

The winning oil mill, as well as the finalists, will be the focus of a dedicated special press report. The winner of the contest will have the opportunity to showcase their mill during the festival.

### ARTICLE 10

**The aim of The Awesome Oil Mill contest**, devised by oleologist Luigi Caricato for *Olio Officina*, is not an end in itself but rather, through this venture, we intend to encourage entrepreneurs to invest in beauty, because taking care of and enhancing beauty is a concrete way of contributing to improving the workplace, while at the same time focusing on the wellbeing of workers and further striving to achieve that total quality to which we all aspire, while at the same time cultivating the ethics of beauty hand in hand with full respect for our environment.
